Part II: Research, Teaching, and Clinical Contributions

A. Narrative report of Research, Teaching, and Clinical Contributions

My research activities have included both basic science research and clinical research. I have a strong background in immunology and have completed a thesis on the innate immune responses in HCV infection. I continued my interest in HCV immunology during my fellowship at BIDMC by investigating the T cell responses in HCV/HIV co-infection. Since fellowship, I have focused on clinical research. I am the principal investigator in a number of clinical trials including investigation of new antiviral therapies for CMV following liver transplantation, the use of Rapamycin in liver transplant patients for treatment of renal dysfunction, and a trial of extracorporeal liver assist devices (ELAD) for acute on chronic liver failure. Additionally, I have a number of clinical research programs studying various aspects of end stage liver disease including the treatment of HCC with radiofrequency ablation, studying the effect of end stage liver disease on avascular necrosis of the hips and determining prognosis of ESLD by radiological imaging with CT scanning and Fibroscan. I am co-investigator on many trials evaluating novel antiviral agents in both HCV and HBV infection.

My clinical practice is based at BIDMC with 6 outpatient sessions, 1 procedure session and in-patient care. I supervise 6 dedicated transplant coordinators, hepatology fellows, rotating residents and nurse practitioners in the Hepatology Division. I chair the liver transplant selection committee and maintain evidenced-based protocols for the management of pre- and post-transplant patients. I am the Chairperson of the Quality Improvement Committee in the transplant center.

I am on Hepatology service for 12 weeks per year and participate in the Medical teaching attending service for 1 month each year.
