The Global Health Track

The Global Health (GH) Track will mark its 13th year at BIDMC this calendar year. The GH Track was launched in 2011 to provide the contextual, clinical, and research experience necessary to become advocates in addressing global health inequities. The track is directed by Dr. Jon Crocker, Attending Hospitalist, Associate Program Director of the IM Residency, and Founding Director of the Global Health Fellowship in Clinical Medicine within the Department of Medicine. Thirty-nine residents have participated in the GH Track to date.

Starting in their PGY2 year, GH Track residents engage in a 1.5-week intensive bootcamp experience with other Boston-area residents and global health fellows from several national programs to dive deeply into the contextual challenges of global healthcare delivery (prior sites include Haiti, Mexico, Boston, MA, Tuskegee, AL, and Peru). GH Track residents engage in a two-year didactic curriculum including monthly global health case conferences with our extended program team in Botswana (see below). Residents complete two four-week global health rotations, one each in their PGY2 and PGY3 years. The primary global health clinical rotation site is at Scottish Livingstone District Hospital (SLH) in Molepolole, Botswana, though GH Track residents have engaged in experiences in more than 15 other nations around the world, including several Native American tribal nations.

The BIDMC Department of Medicine (DOM) directs a global health program in Botswana in partnership with Oregon Health Sciences University (OHSU) Department of Medicine, the Botswana Harvard Health Program, the Botswana Ministry of Health, and the University of Botswana School of Medicine (UBSOM). The partnership works to augment medical care of patients at SLH through medical education of Batswana medical students, interns, and medical officers, clinical stewardship, and quality improvement research initiatives with SLH medical staff. During this time, more than 250 US IM residents (80 from BIDMC -- including GH Track and non-Track residents) from more than 20 US IM residency programs have rotated through

our IM partnership program in Botswana. These clinicians have collectively contributed to the training of more than 80 Batswana medical students and more than 100 medical interns from UBSOM.

The first two in-country faculty directors of the program in Botswana were former BIDMC IM Residency Training Program graduates, Dr. Dagan Coppock (2011-2013) and Dr. Tomer Barak (2013-2020). In August 2023, the program achieved a long-term goal of hiring a Motswana physician, Dr. Kesefogetse ("Kese") Chabaesele, to take the helm as in-country site director. "In Botswana, we aspire to create an informed global health program, grounded in an ethical partnership which leverages the strengths of BIDMC's residents to support the achievement of goals co-created with our Batswana colleagues," said Dr. Crocker. "I continue to be inspired by the compassion, humility, innovation, and commitment that our residents bring to the Track and their work, whether in Botswana or elsewhere. On a recent leadership visit in March, with our Chair, Dr. Mark Zeidel, and Residency Program Director, Dr. Chris Smith, we heard repeatedly about the quality of education, training, and research which our program catalyzes. SLH has become the most desired of six sites to which Batswana interns can be assigned for their intern year. The legacy that BIDMC residents have established and continue to build through this program is simply amazing."

From the Chair

Below is a leadership message Mark Zeidel, MD, Chair of the Department of

Medicine, shared with our Department to honor the passing of Howard Hiatt, MD.

Howard Haym Hiatt, who served with enormous distinction as Physician-in-Chief and Chair of Medicine at Beth Israel Hospital from 1963 to 1972, passed away early this week at the age of 98. The child of Lithuanian Jewish parents (fittingly, his middle name means "Life" in Hebrew), Howard grew up in Worcester, and, despite his outstanding academic record in high school, was denied admission to Harvard until his school principal intervened with the admissions office. His academic record at Harvard College was stellar, and he graduated from Harvard Medical School with Honors. Early basic research experiences led him to join the laboratories of Jacques Monod in Paris, where he helped discover mRNA and



define its roles in cellular biology. He was recruited to serve as Physician-in-Chief and Chair of Medicine at Beth Israel in 1963, and built on the foundations laid by Herrman Blumgart to strengthen the hospital's patient care, research, and teaching missions. He developed the hospital's basic research portfolio, presaging the movement of our research into molecular biology. With Mitch Rabkin, he extended the hospital's work to partner with community health centers, because he recognized that enhancing the care of the most vulnerable was the best way to improve the health of society as a whole. An outstanding clinician and teacher, he continued to strengthen our patient care and teaching missions. Most importantly, in all he did he embodied the traditions of excellence combined with altruism which form the core of our culture. In 1972, while he was being recruited to be Dean at Yale, Harvard's president asked him to serve as Dean of the Harvard School of Public Health. During his time as Dean (1972 – 1984), Howard markedly enhanced all aspects of the School, broadening its research mission and recruiting and developing a galaxy of outstanding researchers. He also helped create the Program in Clinical Effectiveness, which has trained an enormous number of physician leaders in outcomes and health services research. When he retired as Dean, he focused his efforts on extending healthcare to the most disadvantaged, helping found Partners in Health and developing the Division of Global Health Equity at the Brigham. During my time here, I had the privilege of meeting with Howard for lunch from time to time, and he joined us at the Hiatt-McPherson pro-tem dinners when he could. He maintained a keen interest in our hospital and department, and I was pleased to update him and to share with him some of the department archives from the period when he was Chair.

Wherever Howard went, he added to and strengthened the excellence, effectiveness, and beneficence of the programs and people he worked with. To paraphrase General Sherman's appraisal of Abraham Lincoln, Howard Hiatt combined greatness with goodness to an extraordinary degree. His life has been a blessing to the many many people whom he has touched.

Harvard Combined Rounds

Early in COVID-19, two friends (one from BIDMC, one from MGH) met for mutual support on a video call one Saturday night, and had an idea. What if, in the midst of pandemic uncertainty, the Harvard medical community could come together to share knowledge and resources? From there, the Harvard Combined



Medicine Grand Rounds series was born. A collaboration between the Departments of Medicine at BIDMC, Massachusetts General Hospital, and Brigham and Women's Hospital, the initial lecture series featured panel discussions with experts who explored timely COVID-19 related topics from transmission to vaccine development. Experts from near and far, including Dr. Anthony Fauci, participated in the monthly livestream broadcast to thousands of viewers in Boston and around the globe.

Now held monthly, the series has expanded and developed. The focus has shifted from COVID to include other pressing topics across medicine and society. These panel discussions have tackled numerous topics and hosted leaders in both the HMS community and on the national level. Last year, Secretary John Kerry joined a session about Climate Change and Health. In September, our researchers presented a Turing Test exploring the implications and opportunities for the use of AI in healthcare diagnosis. Last month, DEI leaders at BIDMC, HMS, and other institutions discussed how we can move towards inclusion for minority groups in healthcare and beyond. The series has become an invaluable opportunity to connect to a wider medical community and learn from one another, and has spawned a number of cross-institutional collaborations.
